

**REJECTION OF UNINSURED AND UNDERINSURED MOTORISTS
COVERAGE SELECTION OF LIMIT OF LIABILITY
(Alaska)**

Alaska (Sections 21.89.020 and 28.20.445), as amended, permit you, the insured named in the policy, to reject Uninsured and Underinsured Motorists Coverage in its entirety or to reject Law only a portion of the Coverage. If Uninsured and Underinsured Motorists Coverage is not rejected, you may select a limit for bodily injury lower than the limit for Bodily Injury Liability Coverage provided in your policy, but not lower than the basic financial responsibility limit set forth in Alaska Statutes 28.20.440 and 28.22.101 as amended. If the property damage portion of the Uninsured and Underinsured Motorists Coverage is not rejected, you may select a limit higher than such basic financial responsibility limit.

Uninsured and Underinsured Motorist Coverage Provides insurance for the protection of the persons insured under the policy who are legally entitled to recover damages from owners or operators of uninsured or underinsured motor vehicles because of bodily injury or death, or for damage to or destruction of the covered motor vehicle, or both.

In accordance with Alaska Law (Section 21.89.020 and 28.20.445), as amended, the undersigned named insured (for each insured in the policy)-
